# FHSU STAFF SENATE Meeting Minutes

# December 13, 2022 Stouffer Lounge, Memorial Union and Zoom - 1:30 pm

- I. President Bob Duffy called the meeting to order at 1:30 pm.
- II. President Bob Duffy passed around a survey for Senators to vote on ideas for staff appreciation
- III. Roll Call of Members:
  - a. Per the attached Roll Call Register

#### IV. Guests:

- a. The American Democracy Project (ADP) Letter of support for polling place
  - i. Grace McCord and Madison Albers presented on their initiative to bring a polling place to campus
  - ii. Need:
    - a) Most other institutions have a polling place on campus
    - b) Get students engaged in Hays politics
    - c) FHSU is below the national average of campus voting rates
    - d) FHSU voter registration is in line with averages, we just need to get them to the polls
    - e) Voting rate of registered FHSU students is 75%
  - iii. Proposal:
    - a) Move current 601 Main Street polling location to the FHSU Memorial Union
    - b) It would affect roughly 70 community individuals
  - iv. Concerns:
    - a) Location: Memorial Union high traffic area that is ADA compliant
    - b) Parking: Campus PD supports opening CATS building parking lot and being slow on ticketing on voting days
      - i. Campus PD expressed that safety would not be a concern
    - c) Poll Workers: SGA, student organizations/clubs
  - d) Costs: minimizing costs by moving instead of creating new location v. Questions from Staff Senate:
  - V. Questions from Staff Senate:
    - a) Will students have to vote based on their home town address?
      - i. They would still have to utilize mail in ballots to vote on home issues
    - b) What feedback have you had from the community?
      - i. They're still setting the groundwork
      - ii. Have considered attending Hays and county commission meetings
    - c) Have you looked into establishing a new location?
      - i. Costs of purchasing new polling equipment is the #1 barrier
    - d) What efforts have been made to better educate the student population?
      - i. Efforts have been made and will continue to engage local government representatives
      - ii. Times Talks have been ongoing
    - e) Would the voting location be open to all employees and students?

- i. Only those who live in the designated polling site location area
- f) How many people are registered to vote at the current Main Street location?
  - i. Guest Les Mackey thought it was around 200
- g) What is student interest?
  - i. Past efforts had gained 700 signatures 4 or 5 years ago
- h) Would it be open to early voting which would open it up to more people vs. only those who live in the area?
  - i. That is a possibility to explore depending on success of initial push
- i) What is the plan if the Ellis County Clerk says no?
  - i. Go back to the drawing board to see if it's worth fighting for
- j) Are there accessibility benefits of FHSU location vs. current polling place?
  - i. All buildings for polling have to be ADA accessible
  - ii. No clear advantage of FHSU over current location
- vi. ADP is requesting a letter of support from Staff Senate to take with them to the County Clerk
- vii. The Senate will discuss and vote during New Business
