- 8) Cabinet Update: Cabinet met on February 28th.
 - a) President Nicole Frank shared: VP Wintch presenting on budget at March meeting. Our Events/Promotion Committee held Staff Social on February 20th, hosted by Student Success; and is currently working on a celebration for the end of the year. Our March Staff Member of the Month is Raeleann Weigel. Elections for senators will be held in April, with elections for officers in May, and the new senate will be installed at our June

meeting. We are also wrapping up our year by revisiting our recommendations from April 2023, and making revisions as appropriate.

b) Notable items:

- i) The Higher Learning Commission (HLC) has voted to continue our accreditation, with our next Reaffirmation of Accreditation in 2033-2034.
- ii) A new email policy was presented for first read; this policy will discontinue email services for former students one year after they leave the University (for any reason), due to the high cost of maintaining these accounts. Retiring faculty and staff may still request ongoing access.
- iii) Mold update: The company contracted should finish McMindes by about March 1st and will then move on to Victor E Village. They are not finding a lot of mold. They are covering students' possessions, removing all allergens from rooms, and using an air scrubber.
- iv) There will be a legislative coffee at Hays Public Library on March 2nd, sponsored by the Chamber. The president's office is putting some questions together. These events are held the first Saturday of every February, March, and April each year. Questions for coffee's can be sent ahead of time to hayscc@hayschamber.com. The Chamber updates their Facebook events with which legislators will be attending.

 - (1) No meeting yet
- ii) Staff Development (Bob Duffy)
 - (1) Funded 17 applications and next deadline is May 1st which will be the last deadline for this fiscal year.

d) Shared Governance

 - (1) No report have meeting March 5th

 - (1) Did their allocations for all their student organizations, a very long process. Shooting Sports and Rodeo get the highest funding allocations for this.
- iii) AAUP (Nicole Frank)
 - (1) AAUP met on February 21st, (They did not meet in December or January). Notable topics included Program Review. The AAUP executive team met with University administration and Faculty Senate President Elodie Jones to discuss the processes associated with program review initiative by KBOR, in which programs were identified for either Action Plan, Merger, or Discontinuance. The MOA Article 25 outlines processes should a program be recommended for discontinuance. The University has made an official statement via the provost that we have no intention to waive our program discontinuation process outlined in our MOA, and do not plan to submit any discontinuance plans to KBOR through the 24-25 process. In the event that this changes, the University will follow the MOA process.
- iv) Updates from President Mason (Nicole Frank)
 - (1) The University has hired Restore & Clean to perform heavy duty cleaning of McMindes and Victor E Village. The mold report said we didn't need to do Victor E. but we did it anyways. This will be an ongoing process, taking about one month to do each hall. Students are being given notice that their room will be done about 48 hours in advance and their individual rooms should each take a few

hours to clean. David Bollig will meet with students in halls, explaining the process. DEI is still a significant topic at the state level, and we may have to certify that there is no DEI initiative in certain processes.
