

**Art 480 Undergraduate Readings in Art History**

**Course Information:**

Pre-requisite: Completion of at least six hours of art history coursework, along with instructor permission. Exceptions can be made at the instructor's discretion.

The readings course consists of a collaborative arrangement between the instructor and the student and is geared toward the student's scholarly interests and course of study. The course is comprised of relevant guided readings and culminates in some form of scholarly writing (options outlined below).

1. You can write separate formal analysis and research papers on topic/s of your choosing; each paper should be 8-10 pages in length. The formal analysis is due around midterm, and the research is due at the end of the semester; official due dates TBD.

**--OR--**

2. You can combine the formal analysis and research assignments for ART 480 into a single, larger paper (15-20 pages in length), which would be due at the end of the semester; again, official due dates TBD.

3. In lieu of one or two large papers, the instructor and student can collaboratively compile a reading list based on the student's art historical interests; the student will submit bi-weekly critical summaries over the readings (each 2-3 pages in length, totaling approx. 15-20 pages by the end of the semester); due dates will be assigned.

**Important:** The following information has been formulated to provide instructions regarding each of the above-mentioned options.

Formal Analysis: approximately 8-10 pages

topics must be discussed with and approved by the instructor

The student will choose a specific work of art or a series of works related to their interests and/or field of study. The paper will consist of a discussion of the formal aspects of the work of art, including, but not limited to, line, shape, form, color, space, balance, and texture. While content and cultural context of the work of art is not necessarily part of the formal analysis, it certainly may be addressed if it is relevant.

Remember, this is **not** a research paper; rather, it is a demonstration of the student's formal analysis skills. Once the instructor and the student have agreed upon a topic, it may not be changed without instructor approval.

Critical Research: approximately 8-10 pages

topics must be discussed with and approved by the instructor

The in-depth, critical research paper should be a comprehensive treatment of a particular topic. Unlike the formal analysis paper, it is not a personal commentary on a work of art, nor is it merely a compilation of other scholars' writings; it is a critical consideration of the topic, as well as the scholarly research pertaining to the topic.

Bi-Weekly Critical Summaries: 2-3 pages each; 8 total summaries

topics must be discussed with and approved by the instructor

Some things to consider in the critical summaries:

- discuss the author's thesis and how the author supports their argument;
- Is the argument structured effectively? Why or why not?;
- What are the pros and cons of the article (in terms of content, structure, readability, etc.);
- Has the author used evidence to support their work? If so, what kind of evidence? Provide specific examples;
- Who is the audience of the article--general, academic, niche, hobbyist, etc.?

**NOTE:** Page length does not include the title page, endnotes, bibliography, or illustration pages. Illustrations should be placed at the end of the paper, not within the written text. Each paper should be submitted in the Chicago/Turabian style, and typed in Times New Roman, 12-point font. Please use standard one-inch margins for the entire document.

**Once the instructor and the student have agreed upon a topic, it may not be changed without instructor approval.**

Lack of illustrations or identification of artworks, or a lack of sufficient footnotes or bibliography, will be considered plagiarism. Remember, a direct quote from a book or article, or even an explanation or re-wording of another person's idea, requires a source – failure to use citations will also be considered plagiarism.

Please make sure all articles are from a scholarly source. If you have questions regarding the validity of a source, please ask!

Research Paper            300 points

Combined Paper           600 points

Bi-weekly summaries    75 points each (8 total)

An Incomplete (or "I") grade will only be given in extreme circumstances and at the discretion of the instructor.
