- 3:32 (1 minute) All members were present with the exception of Miller and Stanley. Schmidt served as proxy for Miller.
- 3:33 (0.3 minutes) The minutes from October were approved.
- 3:33 (2 minutes) Chair reported that he met with Karmen Porter, chair of Communication Sciences and Disorders, and that the department has decided work up a proposal for *SLP 480: Principles of Research in Communication Sciences and Disorders* to serve as their course satisfying the information literacy outcomes (1.4). They will drop their previous proposal to use the course to satisfy the three upper-division writing and critical thinking outcomes (1.1A.1, 1.1A.2, and 1.5.3). See the minutes from September 16, 2021 for our consideration of that proposal.
- 3:35 (1 minute) The committee *approved* the proposal from the Department of Music and Theatre for *THTR 122: Acting* to satisfy the outcomes for *objective 2.1A (aesthetic mode of inquiry)*.
- 3:36 (14 minutes) The committee considered a proposal from the Department of Music and Theatre for *MUS 291: Rock Music Styles* to satisfy the outcomes for *objective 2.1A (aesthetic mode of inquiry)*. The proposal was *approved contingent* upon two things being resolved: (1) determining whether the name of the course is "Rock Music Styles" or "American Popular Music," and (2) importing something like the language from the student-facing rubric that goes with the listening journal assignment (proficient = "four to five concepts and characteristics of the music are clearly explained using accurate vocabulary") into the CORE rubric for outcome 2.1A.1.

- 3:50 (6 minutes) The committee considered a proposal from the Department of Music and Theatre for **MUS 361**: **World Music** to satisfy the outcomes for **both objective 2.1A (aesthetic mode of inquiry)** and **objective 3.2 (intercultural competence)**. The proposal was **approved contingent** upon something like the language from the student-facing rubric that goes with the written concert report assignment (proficient = "four to five concepts and characteristics of the music are clearly explained using accurate vocabulary") being imported into the CORE rubric for outcome 2.1A.1.
- 3:56 (3 minutes) The committee *approved* the proposal from the Department of Philosophy for *PHIL 330: Bioethics* (formerly IDS 400) to satisfy the outcomes for *objective 2.1E (philosophical mode of inquiry)*.
- 3:59 (1 minute) The committee *approved* the proposal from the Department of Philosophy for *PHIL 331: Ethical Issues in the Professions and Business* (formerly IDS 401) to satisfy the outcomes for *objective 2.1E (philosophical mode of inquiry)*.
- 4:00 (1 minute) The committee *approved* the proposal from the Department of Philosophy for *PHIL 335: Conceptions of the Mind* (formerly IDS 440) to satisfy the outcomes for *objective 2.1E (philosophical mode of inquiry)*.
- 4:01 (1 minute) The committee *approved* the proposal from the Department of Communication Studies for *COMM* **100:** *Fundamentals of Oral Communication* to satisfy the outcomes for *objective 1.1B (oral communication)*.
