 - a) Tammy Wellbrock has been hired as the Interim Alumni Director.
 - b) Brett Gerber has been hired as the Internal Auditor.
 - c) August convocation will mirror spring convocation with information being shared via a website and a live event to present the award recipients.
 - d) New course notations for on campus courses will be completed by July 1. Only select classes will be face to face and those will have to be completed by October 8th. All the rest of the F2F classes will either be Hybrid or Totally Online.
 - e) Student Residential Life has announced its plan for the upcoming Fall 2020 semester. Details of the plan can be found on the COVID website. Res Life will not be asking for volunteers this year during move-in
 - f) The Health Care Commission voted to reduce the number of HealthQuest credits required for eligible members enrolled in the State Employee Health Plan to receive the 2021

premium incentive discount. The credit requirement was reduced from 40 to 20, and HAS/HRA dollars awarded for each Health Quest credit completed has been increased from \$10 to \$20 per credit up to the maximum of \$500 per semester. This change applies only to the 2020 plan year.

- h) As of 6-22-20 for fall we are down 6.85%
- i) Sports schedules of all sports have been modified by the NCAA and are reducing dates/games of competition.
