- III. Approval of Minutes: A motion was made by Nicole Frank and seconded by Diana Staab to approve the meeting minutes from November 10, 2020. The motion was carried.

- VII. Cabinet Update: Jennifer reported as of Dec 2<sup>nd</sup>, 2020:
  - a) COVID policies will remain the same for the spring semester; CDC will be making changes to quarantine timing and any changes for FHSU will be coming out from CPIG
  - b) Foundation: Journey Campaign has exceeded its goal-looking at 3 potential dates for celebration (June, August, October)
  - c) Enrollment: # for Spring is down 6% for pre-enrolled, but have improved last few weeks
  - d) Admin & Finance: Workday student registration will go live for Fall 21. They noted 3 retirements in December and January: Kaleen Fisher, Mary Meier, and Jim Schreiber
  - e) Facilities: Center for Student Success building going well and on schedule; Campus Master Plan kickoff meeting is scheduled for January
  - f) Reminder: Fall commencement is Friday all virtual- give shout outs on social media- Each college has a ceremony.
  - g) Student Affairs: great turnout for tree lighting; Care Teams have been revamped and will be restarting. Director of Student Health and a Physician in Student Health are retiring in January
  - h) URM is revising the President's Office and Sternberg's websites and created a new website at.fhsu.edu that is a news site for prospective students

- i) Alumni: looking at revamping events because of COVID; also will be delaying the award nominations for Homecoming 21 and the new deadline is March 1, 2021
- j) Athletics: lots of athletes screening and testings; have had 3 successful games so far

## VIII. Reports

- a) Staff Senate Committee
  - a. Bylaws Committee-Liz reported that the committee will meet in January.
  - b. Goals Committee- Staci reported the committee meet on 12.7.2020- discussed staff awards, support for long term employees, and the ability for growth for employees
  - c. Scholarship Committee- meeting early spring to discuss application process and rubric
- b) KBOR Groups/Committee
  - a. Satisfaction Survey Committee Meeting early spring semester
  - b. UPS Council- Jennifer reported
    - i. SCOPS agreed to align spring break with all schools in the state (school districts, institutions) starting in 2022. Spring breaks will be around the third week of March.
    - ii. KBOR discussed deferred maintenance on 1,000 buildings across the state
    - iii. School Reports:
      - 1. ESU: No spring break but two Fridays in spring classes are canceled to give students a break; starting to look at combining senates for representative purposes
      - 2. K-state: canceled Fall Commencement; SGA is proposing a few mental health days in the spring semester
      - 3. KU: Paid time off between Christmas and New Year's. Inclement weather policy being reviewed; RPK Group has been hired for almost \$1M to do a complete re-evaluation of every single full-time employee-look at workload distribution, management setup, etc.; Students requesting three days of no classes in the spring and Faculty Senate is supportive.
      - 4. PSU: Held seven commencement ceremonies the weekend before Thanksgiving that included spring grads. Faculty Senate voted against having mental health days during the spring semester. 70% said no and 30% said yes/no opinion.
      - 5. WSU: UP and USS Senates both voted at our November meeting to approve the Constitution of the WSU Staff Senate. If approved, the two Senates will officially merge on July 1, 2021. Employees will not have to use accrued leave on Dec. 21-23. SGA created a resolution for two mental health days in spring. Classes won't be canceled but faculty are encouraged to consider canceling classes and these days will also be used to promote resources on campus.
    - iv. Tuition Benefits- discussing a policy across schools that you can use home institution benefits at another state institution for programs your home institution doesn't offer and benefit would be the up to the amount you would receive at your home institution
    - v. Satisfaction Survey- the cost has increased- needing University approval
  - c. USSC Conference Call- Lisa Lang reported
    - i. School Reports:
      - 1. WSU: Asked for representation for President search for UPS, USS, and Faculty.
      - 2. KU: If Provost will not pay for the survey, the Senate would pay for it.

- 3. ESU: Paid holiday for three days before winter break
- 4. K-State: Offered Administrative leave between Christmas and New years. Find the survey valuable and hopeful their administration will continue support.
- 5. FHSU: USS has not reported to KBOR or COPS this year
- d. University Committees

  - ii. Staff Development- Jenna Niblock reported they do not meet, they just review the applications and how much money they recommend via email.
