## **Daily Crime Log**

Federal law requires that every university that "maintains a police or security department of any kind shall make, keep, and mainta written in a form that can easily be understood, recording all crimes reported to such police or security department" including the r and general location of each crime and the disposition of the complaint, if known. The law requires that this initial information be o inspection within two business days of the report of the crime unless the release of the information would jeopardize an ongoing in a suspect to flee or result in the destruction of evidence. It also requires new information about the entries be made available within days. All crimes reported to the FHSU Police Department are included in this log. Every attempt will be made to have the log updat Monday through Friday.
