Academic Affairs

- Jill reviewed the three goals for Academic Affairs for the new academic year. Their goals will include focusing on results, building community within and external, and data.
- Academic Affairs will also be focusing this academic year in getting the internal program review process updated.
- The search for the Dean of College of Business and Entrepreneurship will kick off in mid-October with the hope of wrapping up the search by Spring Break for the new Dean to start in July. A search firm will be used to run the search.
- Academic Affairs will be hiring three new professional advisors. One new
 professional advisor has been hired in the Health and Behavioral Sciences College.
 A search will be launched for the other two advisor positions. These two advisors
 will work with specific populations, but not a specific college.

- Dale, Donnette and Jill had a meeting with the Kansas Leadership Center, along
 with representatives from the other regent institutions. KLC plans to host something
 for student leaders about how to have productive dialogue about difficult topics and
 engage students in the conversation. The regent schools will provide feedback to
 KLC and they will bring the group back together to share their plan.
- The second group of 50 staff will be going through the Kansas Leadership program during the fall semester.
- Jill gave a sincere thank you for the recruitment, financial aid, move-in, and programming for all the on-campus and online students to start the fall semester.

- FHSU was down 7 percent in FASFA applications this year. The national average was down 12.4 percent.
- FHSU distributed over 8 million dollars on the first day of disbursement, which was more than last year.

- Dr. Curtis and Dave spoke to the KAMS students.
- Memorial Union has seen steady traffic.
- Health & Wellness Services is already busy seeing students.

KAMS/AMS

- Enrollment is at 75 students with 45 juniors.
- Sessions were held to acclimate the international students to campus and Hays community.
